SERVICES–The Flow Center offers hypnosis services to the general public.

The Flow Center's services are not represented as any form of health care or psychotherapy and, despite research to the contrary and by law, it makes no health benefit claims for any services.

2. INSURANCE–Health Savings Accounts (HSA) and Flex Spending Accounts cover our fees.

Medical insurance does not cover hypnosis services. In some situations, insurance will pay a portion if prescribed by a physician. It is your responsibility to check with your insurance provider for your benefits. The Flow Center does not file insurance but will furnish a receipt for services rendered with appropriate medical coding upon request.

- 3. CONFIDENTIALITY-The Flow Center will not release any information to anyone without a written authorization from you. You have the right to be allowed access to your written record at any time.
- 4. APPOINTMENT CONFIRMATION-A \$150 deposit is required to schedule your first session.
- 5. FEES–Fees may be paid by cash, check, Zelle or major credit card, Google and Apple Pay. You agree to pay any costs and fees, including, without limitation, collection or legal fees The Flow Center incurs in order to collect any fees you owe. We do not offer refunds for unused prepaid sessions. Returned check charges are equal to the bank fee plus a \$15 processing fee for makeup payment using a credit card.
